040 Pain Management and Opioids: Balancing Risks & Benefits 2022 UPDATE

Wendy Wright, DNP, ANP-BC, FNP-BC, FAANP, FAAN, FNAP

There is a need for advanced practice nurses to increase their knowledge and skills regarding the latest evidence for managing pain in patients and to apply that information to their practices to improve their patient outcomes. This newly updated course is designed to meet the FDA's Opioid Analgesic REMS. By the end of this session, the learner will be able to describe the pathophysiology of pain as it relates to the concepts of pain management, accurately assess patients in pain, develop a safe and effective pain treatment plan, identify evidence-based non-opioid options for the treatment of pain, identify the risks and benefits of opioid therapy, manage ongoing opioid therapy, and recognize behaviors that may be associated with opioid use disorder.

The course curriculum is fully compliant with the FDA's September 2018 FDA Blueprint for Opioid Analgesic REMS Education and the 2022 Centers for Disease Control and Prevention (CDC) Clinical Practice Guideline for Prescribing Opioids for Pain. This session also meets many states' requirements for controlled substances CE. The curriculum was developed by the Collaborative for REMS Education (CO*RE) <http://core-rems.org> and is supported by an independent educational grant from the Opioid Analgesic REMS Program Companies (RPC). Presented in partnership with the Nurse Practitioner HealthCare Foundation, a member of the CO*RE Collaborative, nine interdisciplinary organizations working together to improve pain management and prevent adverse outcomes.

As more states adopt full practice authority and expand signatory authority, nurse practitioners across the country are faced with a new responsibility, completing death certificates. Death certificates serve many purposes including closure for a family planning final arrangement, information for disease tracking, and important health information for state and federal statistic systems. This program will review the history of death certificates since the 16th century, essential information for death certificates, diagnoses to avoid, and state guidelines and penalties. Cases studies with mock death certificates will be used to present the correct completion method and diagnoses to avoid. 220 When Grandma Really Has "Seen It All": Trauma-Informed Care in Assisted Living

Understanding a person's past experiences is often the key to understanding behavior, care preferences, and values. Behavioral challenges or care resistance should be assessed with an attention to potential trauma exposure. How often are residents labeled as "noncompliant" or "difficult" without considering triggers? Using a case-based approach, we will explore the six principles of trauma-informed care: safety, trustworthiness and transparency, peer support, collaboration and mutual support, empowerment, and cultural and historical sensitivity. Attendees will gain awareness of how to identify prevalent types of trauma in assisted-living residents, design a care plan that meets the psychosocial needs of the resident, and understand the role of the nurse practitioner as leader of the interdisciplinary team.

243 Hearing Loss: The Invisible Disability Impacting Cognition, Falls, and Function and Practical Communication Strategies

Hearing loss is a major cause of dementia. Hearing loss is also associated with social isolation, falls, depression, poorer physical function, and higher health care costs. Despite the high prevalence of hearing loss, healthcare providers often do not recognize or employ strategies to address this communication need. Providers need to know the appropriate options to ensure good communication with patients, how to recognize hearing loss, and how to implement methodologies and practical strategies to address communicating with someone with hearing loss. This evidence-based presentation includes the impact of hearing loss on health and quality of life; types and assessment of the various levels of hearing loss; health-care provider and patient communication strategies for primary and acute care settings, education, and resources; when to refer to audiology; types of assistive listening devices; and the pros and cons of over-the-counter hearing aids.

350 Hospital at Home: An Overview

Joseph White, DNP, MSHQS, RN, NE-BC

Many health systems across the country are taking advantage of the telehealth gains made during the COVID-19 pandemic and embracing the use of the hospital-at-home model for patients. Hospital-at-home models enable patients who need acute-level care to receive the care in their homes, rather than in a hospital. This care delivery model has been shown to reduce costs, improve outcomes, and enhance the patient experience. In this session, Dr. Joseph White will share his knowledge and expertise as the director of the hospital-at-home program at the University of Alabama in Birmingham.
