Infection Prevention and Control Assessment Tool for Nursing Homes Preparing for COVID-19

CDC‰Û^as COVID-19 Infection Control Assessment and Response (ICAR) tool was developed to help nursing homes prepare for and respond to COVID-19. The ICAR tool should be used as one instrument to develop a comprehensive COVID-19 response plan. This tool may also contain content relevant for assisted living facilities.

New Guidance: Considerations for Memory Care Units in LTC Facilities

Infection prevention strategies to prevent the spread of COVID-19 are especially challenging to implement in dedicated memory care units where numerous residents with cognitive impairment reside together. This guidance provides considerations for memory care units, including when residents in a memory care unit are suspected or confirmed to have COVID-19.

Making PPE More Effective

A new Cochrane review evaluated the differential impacts of personal protective equipment (PPE) types and methods of donning/doffing on contamination and infection risk for healthcare workers. Researchers found PPE covering more body surface areamay lead to better protection but at the cost of more difficult donning or doffing (e.g., a powered, air-purifier respirator may protect against contamination better than a N95 mask and gown but with less compliance with donning). PPE design modifications may decrease the risk of contamination compared to standard PPE (e.g., better fit around neck, wrists, and hands).
