Better yet, invite them to visit you at your practice. Many law makers have no clue what an APRN is really capable of doing, the extent of our role and why we can be trusted with expanded responsibilities.

### 1) The Home Health Care Planning and Improvement Act

# 2) The Medicare DME face-to-face Encounter Documentation Requirement

This would remove the requirement of physician attestation to the fact that we completed the face-to-face. #### 3) Support for the acceptance of the Veterans Health Administration's (VHA) Nursing Handbook

Changes in the handbook would allow Advanced Practice Registered Nurses (APRNs) full practice authority within the VHA system. This change would be especially helpful in the context of the recent exposure of the service delays within the VHA systems.
